I release and forever discharge Post Enduro Association, Inc., and Lessors, their heirs, personal representatives, successors and assigns and anyone in privity with them, from any and all actions, causes of action, claims and demands for, upon, or by reason of any damage, loss to person or property which may be directly or indirectly sustained during the course of or as a result of my use of the Premises.

I further agree to indemnify and hold Post Enduro Association, Inc., and Lessors, their heirs, personal representatives, successors and assigns, and anyone in privity with them harmless against any and all claims, demands, damages, costs and expenses, including reasonable attorney's fees, for the defense of such claims and demands, arising from the conduct or use of the Premises by me, my guests, family or invitees, or from any act or negligence of me, my guests, family or invitees, in or about the Premises.
